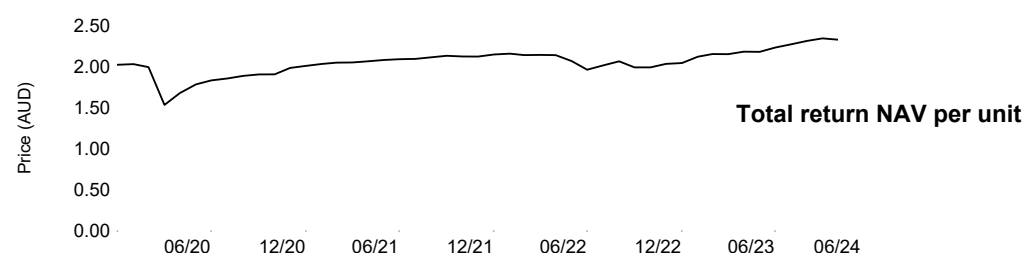

Monthly update

Portfolio commentary¹

In June, the total return (change in NAV plus distribution) per unit was 0.34%. This marks a 5.54% total return since the beginning of the year. The Underlying Fund declared a distribution of 0.0183 per unit which is in line with the distribution target of RBA+4% per annum. Interest income continues to be the main performance contributor adding 78bps to the total return. Single-B assets contributed 14bps, slightly offset by assets rated triple-C and below. In terms of sectors Health Care, Consumer Discretionary and Information Technology contributed 30bps to the total return for the month. The weighted average price of the underlying assets in the Portfolio is 97.3, and the current portfolio yield is 10.7%.

In June, the fund added new direct debt positions to the portfolio by investing in German-based cloud-only provider of managed IT services, an IT management service provider based in US and a fire safety equipment and services provider based in France. Furthermore, the fund achieved a beneficial exit from a leading pan-Asian full-service Contract Research Organization. The investment generated approximately 1.25x TVPI since the 2022 investment.

On syndicated credit, the Underlying Fund focused its activity on the primary market, participating in several transactions, including two new issuances from a leading designer, manufacturer, installer, and a European operator of optician clinics.

Market activity

In June, the US loan market returned 0.35%, while the European market posted a return of 0.14%, bringing year-to-date total returns to 4.3% and 4.9% respectively². Secondary prices declined due to slowdown in CLO creation, ending the month with an average bid for the US and European loan markets at 96.6 and 97.6 respectively.

The unexpected softening of macro data has provided early indications of the impact of restrictive monetary policy on both the labour market and consumer behaviour. Despite this, the credit outlook remains favourable, assuming earnings resilience. In parallel, leverage loans remain on track for robust performance thanks to high base rates and ongoing shortage of net supply.

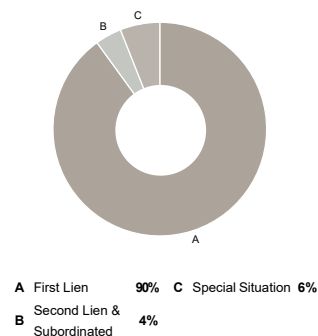
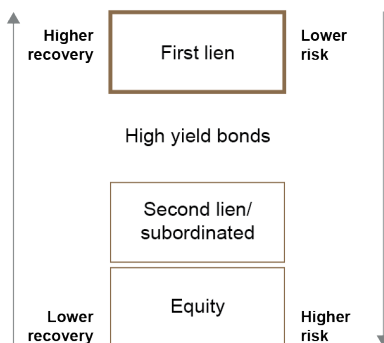

The investment objective is to provide monthly income through exposure to a diversified pool of global private debt investments.

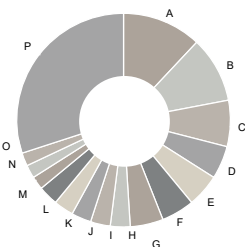
The investment strategy is to access a diversified portfolio of private debt investments through active origination, portfolio construction and risk management. The strategy will be implemented by dynamically allocating investments across the following three distinct private debt strategies:

- The First Lien loan strategy, representing 60-100%
- The Second Lien and Subordinated loan strategy, representing 0-20%
- The Special Situations strategy, representing 0-25%



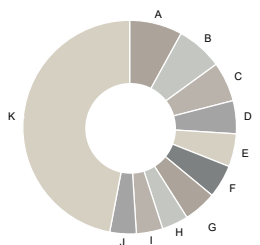
Portfolio diversification¹

Investments by industry sector



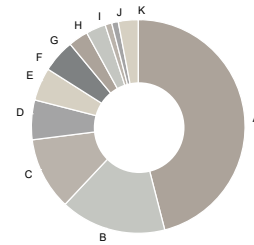
